Speaker Biographies

Anita Ramasastry

Anita is the Henry M. Jackson Professor of Law and the Director of the Sustainable International Development Graduate Program at the University of Washington School of Law.

She is an expert in the fields of anti-corruption, commercial law, sustainable development and business and human rights. She currently serves as the Vice Chair of the United Nations Working Group on Business and Human Rights, having been appointed as a rapporteur by the United Nations Human Rights Council in 2016. Ramasastry is also a founding co-editor in chief of the *Business and Human Rights Journal*, published by Cambridge University Press. She is the Co-President of the Global Business and Human Rights Scholars Association and launched its annual research scholars forum. More recently, Ramasastry chaired an expert panel of jurists to develop the Corporate Crime Principles, focused on when States should investigate and prosecute cross border corporate crimes having significant human rights impacts. In 2019, she served as a commissioner on the Lichtenstein Initiative Commission on Finance against Slavery and Trafficking.

Daria Davitti

Daria holds a PhD in Law and LLM from the University of Nottingham where until 2021 she worked as Assistant Professor in Law and Head of the Forced Migration Unit at the Human Rights Law Centre. She is currently Associate Professor (docent) in Public International Law at Lund University, Faculty of Law (Sweden).

She co-directs two projects focusing on the implementation of the European Green Deal through the EU Taxonomy and the interaction of the latter with mandatory business and environmental due diligence processes at EU level. Her research, more broadly, focuses on the implementation of international law and international human rights law in complex contexts, such as situations of armed conflict, climate breakdown, forced migration, and humanitarian emergencies. Prior to joining academia, Daria served as a human rights field officer with the United Nations (both the former Department of Peacekeeping Operations, DPKO, and the Office of the High Commissioner for Human Rights, OHCHR), and was deployed in Afghanistan from 2006 to 2009. Her research on Afghanistan has been published in a monograph with Hart Publishing (2019) on the protection of the right to water in the context of extractive sector investment.

He sits on the Executive Committee of the Inter-American Institute of Human Rights and the Editorial Board of the American Bar Association's Key Business and Human Rights Documents. He is counsel before the US Supreme Court for former US diplomats and international development practitioners, as amici curiae in the case of Jam v. International Finance Corporation, which they ask the Court to review and to permit the suit against the IFC to proceed.

Her current research explores the responsibilities of multinational corporations to respect international human rights and efforts to hold corporations accountable for alleged rights violations. She is a member of the Advisory Board of the American Bar Association Center for Human Rights, serves on the Board of Trustees of Earthjustice and is a member of the Fair Labor Association Board. She is a member of the editorial board of the Business and Human Rights Journal. She is a Fellow of the American Bar Foundation and was recently elected to the American Law Institute. Prior to joining the University of Utah, Erika was a fellow and later consultant to Human Rights Watch conducting human rights investigations in South Africa on women's rights, children's rights, violence, the right to education and rights abuses related to the HIVAIDS epidemic.

He has published widely on business and human rights and has extensive experience working with and advising States, international organizations, businesses and civil society on business and human rights in international, regional and domestic standard-setting processes and in the implementation of responsible business conduct standards.

Justine Nolan

Justine is a Professor of Law and the Director of the Australian Human Rights Institute, at the University of New South Wales, Sydney, Australia.

She has published widely on business and human rights and her latest book, *Addressing Modern Slavery* (2019) (with M. Boersma) examines how consumers, business and government are both part of the problem and the solution in curbing modern slavery in global supply chains. She advises companies, NGOs and governments on these issues and is a member of the Australian Government's Expert Advisory Body on Modern Slavery. She is the Executive Editor of the *Australian Journal of Human Rights*, a member of the Editorial Board of the *Business and Human Rights Journal* and is a Visiting Scholar at NYU Stern Center for Business and Human Rights. Justine has practiced as a private sector and international human rights lawyer.

He is one of the programme directors of the MA in Human Rights and chairperson of the Interdisciplinary Research Centre for Human Rights Erlangen-Nürnberg (CHREN). He studied law, economics and political science at the University of Hamburg (Germany) and the Florida State University in Tallahassee (US).

His research focusses on international economic law, human rights, European external relations and the law of public services. He is co-editor of the European Yearbook of International Economic Law. He advises international governmental and non-governmental organisations on European and international economic law and acted as consultant in different development cooperation projects. Prior to his current role, he has taught at King's College London and the University of Potsdam in Germany, and was Guest Professor at the Collaborative Research Centre Transformations of the State at the University of Bremen.

In that role, he has prepared policy papers and thematic reports for the United Nations Human Rights Council and the General Assembly, as well as policy advice for governments, companies and advocacy groups. From 2015 to 2016, he served as chairperson of the coordination Committee of the United Nations Special Procedure Mandate Holders.

Penelope is an Associate Professor and Vice Dean Research at the Faculty of Law (Common Law Section), and the Gordon F. Henderson Chair in Human Rights at the Human Rights Research and Education Centre, at the University of Ottawa. She obtained her PhD from the University of Cambridge, UK.

Her research has focused on understanding and examining the international and domestic legal structures and power dynamics that protect and facilitate business activity, and she has published widely. Penelope was co-counsel for Amnesty International Canada in the *Choc v Hudbay* and *Garcia v Tahoe* cases, and for Amnesty International Canada and the International Commission of Jurists in the ground-breaking *Nevsun v Araya* case, as well as for the Canadian Civil Liberties Association in the *Director of Criminal and Penal Prosecutions and Attorney General of Quebec v 9147-0732 Quebec Inc.* She is a member of the editorial board of the *Business and Human Rights Journal*, and Edward Elgar Publishing's *Elgar Studies in Human Rights*, Vice President and a member of the board of the Global Business and Human Rights Scholars' Association, a member of the board of the Canadian Council on International Law and treasurer of the *Canadian Journal on Women and the Law*.

Sarah Joseph

Sarah is a Professor of Human Rights Law at Griffith University in Brisbane, Australia.

Her publications focus on human rights internationally and in Australia, with particular expertise on the International Covenant on Civil and Political Rights, business and human rights, trade and human rights, and issues concerning the media (and social media) and human rights. She has conducted numerous human rights consultancies, including training programs in Vietnam, Indonesia and Myanmar, and in Australia for the Department of Foreign Affairs and Trade, and courses funded by AusAID (including for Iraqi government officials). Prior to her current appointment, she had been a Professor of Law at Monash University, Melbourne and was the Director of the Castan Centre for Human Rights Law for 15 years.
