#### The Membership

- The University of Nottingham ("UoN") David Ross Sports Village Classic Club membership provides access to the Swimming Pool between Monday and Friday between 9am - 12 Noon.
- The UoN David Ross Sports Village Classic Club Membership does not provide general access to any of the sports facilities located on the University Park Campus, the Jubilee Campus and the Sutton Bonington Campus, nor the activities taking place within them.
- The UoN David Ross Sports Village Swimming Classic Club Membership applies to any member of the general public aged 50 or over. Full details of the membership fees can be found athttp://www.nottingham.ac.uk/sport/membership/publicmember-ships.aspx.
- The UoN David Ross Sports Village Classic Club Membership is strictly nontransferable and cannot be resold to a third party.
- The Membership card must be shown, upon reasonable request, to any member of UoN staff.
- A registration fee of £20.00 is payable in full in advance by cash, cheque or debit/ credit card, this cost includes a complimentary swim and additional membership benefits full details can be found at http://www.nottingham.ac.uk/sport/ membership/public-memberships.aspx.
- The member is liable to pay all membership fees due irrespective of actual usage of facilities
- 8. It is prohibited to exchange or loan out the swimming pool membership card for the purposes of allowing others to access the (UoN) David Ross Sports Village Swimming Pool and is a breach of these terms and conditions. Members who allow cards to be used by anyone other than the member identified on the card will incur a 14 day ban during which during which time all membership privileges will be suspended. A second offence may result in termination of membership.
- Access to the UoN swimming pool is granted to members in possession of a valid UoN membership card or Student/staff ID card only. Where members fail to present their card upon arrival on three occasions within a period of each academic term, members will be refused facility access or asked to purchase a membership card for a fiftee.
- 10. A photograph will be required of each member as part of the joining process, which will normally be taken at the reception desk upon joining, or first visit. All photographs are stored digitally within the University booking system and will not be reproduced, shared or printed without prior permission from the member.
- 11. UoN David Ross Sports Classic Club members may sign up for a UoN Sport & Fitness Membership by paying their membership fee and completing the relevant application form in person at the David Ross Sports Village reception. Cancellation
- 12. UoN David Ross Sports Classic Club Membership may be cancelled by the member without reason up to 14 days from the date of purchase (the "Cancellation Period"). The amount refunded will represent the unexpired proportion of the membership and will not include the period prior to the cancellation request. Members who have taken advantage of the membership within this period, will be charged on a prorata basis. - 13. Cancellation and refund of membership fees after 14 days will only normally be considered in cases: (a) of continuing debilitating or serious illness where it can be demonstrated, to UoN's reasonable satisfaction, that exercise may be detrimental; b) where UoN fails to perform its obligations under these terms and conditions (other than in the circumstances set out in paragraph (19) in any material way and does not correct or fix the situation within 14 days of the member asking UoN to do so; or (c) where UoN makes a material change to these terms and conditions to a member's material detriment.
- Refunds will not be given in relation to changes in personal circumstances or preference.

- 15. Refunds will not be given in cases of voluntary cancellation by the Member at any time after the expiry of the Cancellation Period except where a refund is given in the circumstances described in paragraph 13 above.
- 1.6. UoN reserves the right to cancel a member's membership if: (a) the member commits a serious breach of these terms and conditions; (b) any part of the member's membership fee remains unpaid 30 days after its due date for payment; (c) the member provides the UoN with details which the member knows to be false when applying for membership and the false declaration would have reasonably affected the UoN's decision to grant the member membership.

#### Use of University of Nottingham Sport (UoN) David Ross Sports Village Swimming Pool

- 17. When using the UoN David Ross Sports Village Swimming Pool, all members must abide by the etiquette, which is displayed in the relevant sports facility.
- 18. Personal items including clothing and all bags must be left in the lockers provided in the designated areas. To ensure the safety and security of the sports facility, padlocks will be removed from all lockers found to be locked upon building closure; this may result in the destruction of the padlock. Any and all items found within lockers will be recorded and placed within the lost property store. Refund or replacement of locks will not be given in these cases.
- .9. UoN will use its reasonable endeavours to ensure that the UoN David Ross Sports Village Swimming Pool facilities are available during the times permitted by your membership. However the UoN reserves the right to prevent access to the UoN David Ross Sports Village Swimming Pool in the following circumstances: (a) in the event that a member has not paid his/her membership fees or failed to comply with these terms and conditions in some material respect; (b) in order to comply with health and safety regulations which, in the UoN's reasonable opinion, are necessary to protect the UoN's interests and those of the members; (c) to carry out repair, alteration or maintenance works which cannot reasonably be performed outside opening hours;
  - (d) where an event outside of the UoN's reasonable control occurs. Where possible, a minimum of 24 hours' notice will be given; e) bank holidays and UoN holidays when facilities may be closed or operate on reduce opening times.

## Reservations/ Bookings

- 20. Pool sessions can be booked online or in person at a sports centre of your choice or by phone 7 days in advance. If included in your package, health suite sessions can be also be booked 7 days in advance.
- Reservations for Aqua classes taking place at the ("UoN") David Ross Sports Village Swimming Pool may be made up to 3 days in advance and members will be charged a fee of £4.00 for reserving Aqua Classes.
- Indoor court, outdoor court, group exercise classes, climbing wall and snooker reservations can be booked 3 days in advance with an additional charge.
- 23. A minimum of 1 hours' notice is required to cancel a reservation. Should you arrive late to your reservation, and after a reasonable amount of time has elapsed, it may be assumed your attendance is unlikely, in which case your place may be offered to others.
- 24. The UoN reserves the right to make reasonable changes to the UoN sports club timetable throughout the year. Notice in advance will be given where this results in a significant change of availability of UoN Sports Facilities.
- The UoN reserves the right to refuse bookings to customers who consistently fail to honour reservations.
- Reservations are subject to availability and facilities may be unavailable on occasion due to the hosting of major events and competitions by UoN.

## Limitation of Liability

- 27. If UoN fails to comply with these terms and conditions, UoN will only be responsible to members for loss or damage suffered by members that is a foreseeable result of UoN's breach of these terms or its negligence. UoN will not be responsible for any loss or damage that is not foreseeable by UoN or a member.
- 28. Subject to paragraph 39 and 41, UoN's liability to compensate you is limited in any 12-month period to 100% of the membership fees paid by the member in the 12-month period immediately preceding the date of the act or omission giving rise to the claim.
- UoN does not exclude or limit in any way its liability for death or personal injury
  caused by negligence of UoN management, employees or agents or for any other
  liability which cannot be excluded or limited by law.
- liability which cannot be excluded or limited by law.

  30. Members agree that neither UoN nor its employees shall be liable for any loss, damage or theft of any property belonging to, or brought onto the premises by a member, occurring within the facilities unless caused by negligence of UoN management, employees or agents.

### Conduct

- Disorderly, rude or offensive behaviour may result in refusal of entry into ("UoN")
   David Ross Sports Village Swimming Pool and will constitute a serious breach of these terms and conditions.
- 32. Members must use all facilities and equipment in accordance with advice given by employees of the UoN Sport Department and notices suitably posted throughout the buildings. Members shall not abuse the equipment or facilities of the University.
- 33. No member shall bring intoxicating liquor into the facilities, anyone appearing to be under the influence of alcohol and/or drugs will be asked to leave the facility.
- 34. Smoking is not permitted within UoN Sports Facilities.
- 35. Members use the facilities at their own risk; UoN does not accept responsibility for any harm or injury to any customer unless caused by negligence of UoN management, employees or agents.
- Any damage to UoN property shall be paid for in full by any member who wilfully or negligently causes such damage
- Cars parked on the UoN campus are left at the owner's risk. UoN will accept no liability for loss or damage thereof unless caused by the negligence of employees or agents of UoN.

## **Epidemic or Pandemic**

- 38. The health and wellbeing of our members, visitors and staff is taken very seriously. In the event that the UK government or appropriate UK authorities declares an epidemic, pandemic or a public health emergency which results in the temporary closure of our facilities, all sport and fitness memberships will be automatically frozen and re-activated once facilities have re-opened. In such an event, all members will be sent direct email communications to advise of these updates and changes.
- 89. Members are required to adhere to all user guidelines and observe all safety measures that may be in place at any one time - including but not limited to additional pre-booking systems, reduced activity numbers and track and trace processes. Failure to do so will be considered a serious breach of these terms and conditions.

### **Other Material Terms**

- 40. The failure of UoN to enforce any of their respective rights at any time and for any period shall not be construed as a waiver of such rights.
- Members may not sub-let or hire out UoN Sports Facilities for the purposes of coaching or tournaments of any kind.
- 42. UoN shall not be liable to the Member or be deemed to be in breach of these terms and conditions by reason of any delay in performing, or any failure to perform, any of the UoN's obligations in relation to the service, if the delay or failure was due to any cause beyond UoN's reasonable control.
- 43. If any provision of these terms and conditions (or part of any provision) is found by any court or other authority of competent jurisdiction to be invalid, illegal or unenforceable, that provision or part provision shall, to the extent required, be deemed not to form part of these terms and conditions, and the validity and enforceability of the other provisions of these terms and conditions shall not be affected.
- 44. UoN may correct any typographical or other errors or omissions on the UoN website or other promotional materials relating to the UoN Sports Facilities at any time, provided such corrections do not materially affect a member's rights or his/her membership.
- 45. The UoN may employ photographers at certain times during the year, notifications will be displayed at this time, and if you do not wish to be included in any photos please advise a member of the team.
- 46. UoN may transfer its rights and obligations under these terms and conditions to another organisation and will notify the member if this happens, but this will not affect the member's rights or obligations under these terms and conditions.
- Members may not assign their rights and obligations under these terms and conditions to another person.
- This contract is between the member and UoN. No other person shall have any right to enforce any of these terms and conditions.
- These terms and conditions are governed by English law. UoN and members both agree to the non-exclusive jurisdiction of the courts of England and Wales.

## **Health Commitment Statement**

We are dedicated to helping you take every opportunity to enjoy the equipment and facilities that we offer. With this in mind, we have carefully considered what we can reasonably expect of each other.

### Relating to COVID-19 (coronavirus)

#### Relating to Exercise

#### Our Commitment to you

- We will respect your personal decisions, and allow you to make your own decisions about what exercise you can carry out. However, we ask you not to exercise beyond what you consider to be your own abilities.
- We will take reasonable steps to make sure that our equipment and facilities are clean and safe for you to use and enjoy for the normal purpose they were intended for. Bear in mind that we are not able to clean or inspect equipment and facilities after each use.
- We will take reasonable steps to make sure that our staff are qualified to the fitness-industry standards set by the Chartered Institute for the Management of Sport and Physical Activity.
- If you tell us you have a disability which puts you at a substantial disadvantage in
  accessing our equipment and facilities, we will consider what adjustments, if any, are
  reasonable for us to make.

#### Your Commitment to us

- Do not exercise beyond your own abilities. If you know or are concerned that you
  have a medical condition which might interfere with you exercising safely, before
  you use our equipment and facilities you should get advice from a relevant medical
  professional, and follow that advice.
- Make yourself aware of any rules and instructions, including warning notices, and follow them. Exercise carries its own risks. When you are exercising, you are responsible for the risks involved. You should not carry out any activities which you have been told are not suitable for you.
- Let us know immediately if our equipment or facilities are unsafe to use or if you
  feel ill when using our equipment or facilities. Our staff members are not qualified
  doctors, but there will be a person available who has had first-aid training.
- If you have a disability, follow any reasonable instructions to allow you to exercise safely.

This statement is for guidance only. It is not a legally binding agreement between you and us and does not create and obligations which you or we must meet.
