**BEFORE** the Honourable Mr Justice Ritchie sitting at the Birmingham Civil Justice Centre, Birmingham on 7 June 2024.

UPON READING the Application Notice of the Claimant dated 6 June 2024.

**AND UPON** the Court having made an Order dated 20 May 2024 in this Claim and an Order dated 22 May 2024 (as amended under the slip rule on 24 May 2024).

**AND UPON HEARING** Leading Counsel for the Claimant and the First Defendant in person.

**AND UPON** noting that this Court made a 1<sup>st</sup> Order on the same date as this order relating to amendment of the definition of the 5<sup>th</sup> and 6<sup>th</sup> Defendants.

## NOW IT IS ORDERED THAT:

### Possession Order against the Fifth Defendant

 The Fifth Defendant and each of them shall give the Claimant possession forthwith of the areas of land edged red on the plan attached to this Order and marked 'Plan B', being part of the Jubilee Campus at the University of Nottingham.

### Variation of the Orders dated 20 May 2024 and 22 May 2024

- 2. Pursuant to CPR 3.1 (7) of the Civil Procedure Rules:
  - 2.1 Paragraphs 6, 7, 8, 9 and 10 of the Order dated 20 May 2024 shall be revoked.
  - 2.2 Paragraphs 2(a), (b) and (c) of the Order dated 22 May 2024 shall be revoked.

### **Further Directions**

- 3. By 4pm on **12 June 2024**, the Defendants shall file and serve any acknowledgements of service, admission or defences and any documentary or witness evidence in response to the possession claim.
- 5. By 4pm on **14 June 2024**, any further witness evidence in support of the possession claim by the Claimant shall be filed and served.

### Service of this Order and Documents

- 6. Pursuant to CPR 6.27:
  - 6.1 The Claimant has permission to serve: (a) this Order and (b) any witness statements and (c) all bundles for hearings and (d) all other documents which need to be served, on the Fifth and Sixth Defendants by the following method:

- (a) Placing three stakes in the land which being camped on at Jubilee Campus in places where they area clearly visible and attaching to each stake copies of the documents in a sealed transparent envelope addressed to 'the occupiers'; and
- (b) Publishing a copy of the documents on the Claimant's website <u>https://www.nottingham.ac.uk/legalservices;</u> and
- 6.2 Service shall be deemed to have been effected on the Fifth Defendant and Sixth Defendant at 4pm on the date by which service by the methods referred to in paragraph 6.1 has been completed.

### Liberty to Apply

- 7. Any party affected by this Order may apply to have this Order set aside, varied or stayed. Any such application must be made within 24 hours of serve of the Order on that party. Any person applying to set-aside, vary or stay this Order must provide their full name, address and an email address for service, and must apply to be joined as a named Defendant to the proceedings at the same time.
- 8. Liberty to apply to the Claimant upon 24 hours notice.

9. There be no order for costs
