**UPON READING** the Application Notice of the Claimant dated 17 June 2024 and the email from the Defendants solicitors dated 18.6.2024.

#### NOW IT IS ORDERED THAT:

- 1. Pursuant to CPR 3.1(2)(b) of the Civil Procedure Rules:
  - 1.1 The hearing listed for 10.30am on Wednesday 19 June 2024 is vacated; and
  - 1.2 The matter is re-listed for a hearing on the first available date after 25 June 2024 with a time estimate of one day taking into account the availability of counsel for both parties.
- 2. Costs reserved

#### Service of this Order and Documents

- 3. Pursuant to CPR 6.27:
  - 3.1 The Claimant has permission to serve: (a) this Order and (b) any witness statements and (c) all bundles for hearings and (d) all other documents which need to be served, on the Fifth and Sixth Defendants by the following method:
    - (a) Placing three stakes in the land which being camped on at Jubilee Campus in places where they are clearly visible and attaching to each stake copies of the documents in a sealed transparent envelope addressed to 'the occupiers'; and
    - (b) Publishing a copy of the documents on the Claimant's website https://www.nottingham.ac.uk/legalservices; and
  - 3.2 Service shall be deemed to have been effected on the Fifth Defendant and Sixth Defendant at 4pm on the date by which service by the methods referred to in paragraph 3.1 has been completed.

# Liberty to Apply

- 4. Any party affected by this Order may apply to have this Order set aside, varied or stayed. Any such application must be made within 24 hours of serve of the Order on that party. Any person applying to set-aside, vary or stay this Order must provide their full name, address and an email address for service, and must apply to be joined as a named Defendant to the proceedings at the same time.
- 5. Liberty to apply to the Claimant upon 24 hours notice.
