Modern slavery: why it matters to you

- There are an estimated 50 million enslaved people worldwide^[1].
 - That is equivalent to 1 in 160 people, across every country globally.
 - 28 million are in forced labour, affecting commercial supply chains - this number has increased due to climate change, conflict and Covid-19.
- Modern slavery is a persistent and serious threat within many supply chains, and it's bad for business.
 - Human trafficking, including for forced labour, generates \$236 billion of illicit profits every year [2].
 - 76% of CEOs report that ethics and citizen trust is critical to business^[3].
 - 54% of CEOs are strengthening visibility into the social impacts of their company's supply chain^[4].

Pressure is growing

- Target 8.7 of the United Nations Sustainable Development Goals is to take significant action to end modern slavery by 2030 and business action is key to achieving this goal.
- Businesses operating in markets representing over half of global GDP (N America, EU, UK, Australia) are facing formal legal obligations to identify, disclose and address modern slavery risks.
- As a business, you are facing higher reputation and commercial risk, if an issue is found*
 - Businesses need to be able to assess modern slavery risks, but often lack the necessary internal expertise, time capacity or data.
 - Businesses need guidance on best practice approaches for this complex issue in their supply chains but there is limited published guidance.





Some of our discoveries:

- 42% of the world's slavery is visible from space
- Half of all countries have not yet made it a crime to enslave a human being
- 90% of the 3000 conflicts since WW2 have involved slavery
- Modern slavery makes a major contribution to deforestation and tree loss globally
- High levels of globalization, democracy and development are linked to lower levels of slavery
